- Spring 2020 & Summer 2020. Full-time Students eligible for up to \$500.00 and Part-time Students eligible for up to \$300.00 based on application process documenting need and review by Financial to ensure students met applicable restrictions stipulated by statute and the Department of Education.
 - Fall 2020. Students enrolled full-time eligible for up to \$1,600, students enrolled part-time eligible for up to \$500, based on application process documenting need and review by Financial to ensure students met applicable restrictions stipulated by statute and the Department of Education.
 - Spring 2021 Pell Eligible Students. Pell eligible students received \$500.00 if registered for Spring 2021 Semester.
 - Fall 2021. Students allowed to apply for up to \$6,000, and could elect to apply up to \$5,000 directly to amounts owed to the College.
 - Fall 2021 Part 2. Students registered for at least one credit hour issued a \$500.00.
 - Spring 2022 Pell eligible students registered for Spring 2022 classes received \$750.00, all other students registered for Spring 2022 classes who met HEERF requirements received \$500.00.

Spring 2020 & Summer 2020 Instructions

Who is eligible for the CARES Act emergency grant funding?

Students enrolled at least half-time for spring 2020 and/or for summer semester 2020 classes at Cincinnati State who have experienced unexpected expenses due to disruption of campus operations from COVID-19 are eligible to apply for the emergency funding. To receive the funds, students are required to be eligible to receive federal financial aid funds (Pell Grant and/or student loans). Students do not need to be a financial aid recipient but are required to complete the Free Application for Federal Student Aid (FAFSA) and send the FAFSA information to Cincinnati State. If you have not completed the FAFSA you can do so at fafsa.gov.

The following students are not eligible for the CARES Act emergency grant funding:

College Credit Plus students

Workforce Development students

Non Degree students

International students

DACA students

What are allowable expenses?

Allowable expenses may include but are not limited to food, housing, course materials, technology, health care and child/dependent care expenses

How to apply?

Students enrolled for spring 2020 and/or summer semester 2020 can apply for the CARES Act emergency grant funds through myCState. The application is located in the financial aid section of myservices.

How much funding can I receive?

Full-time students (twelve or more credit hours per semester) may receive up to \$500 dollars. Part-time students (six to eleven hours per semester) may receive up to \$300. Students under six hours are not eligible to receive the funding.

Fall 2020 Instructions

CARES Act Emergency Grant Funding – Fall 2020

Students enrolled for six credit hours or more in Fall Semester 2020 are eligible for CARES ACT emergency grant funding, on a first-come first-serve basis.

Students enrolled full-time for Fall Semester (12 or more credit hours) may receive up to \$1,600.

Students enrolled part-time (6 to 11 credit hours per semester) may receive up to \$500.

This funding is for students who have experienced unexpected expenses due to the disruption of campus operations from COVID-19.

The emergency grant assistance for allowable expenses will be provided in accordance with institutional policy and guidance from the U.S. Department of Education.

To receive this funding, students must apply electronically by logging in to MyCState / MyServices, Financial Aid section, and completing the CARES Act emergency grant funding application. Funds are limited.

Spring 2021 No Instructions

Disbursements made directly to Pell eligible students without need for application or action by the student.

Fall 2021 Instructions

On March 11, 2021, the U.S. Congress passed the American Rescue Plan Act of 2021 (ARP). This federal stimulus funding is the third act of federal relief in response to COVID-19, following the CARES Act and CRRSA. The ARP funding received by Cincinnati State Technical and Community College (the College) will be used to help students pay a past due balance as well as provide emergency grants.

The College is aware that the past year and a half has brought about uncertainty and difficult times for our students. To offer some relief, the College is also offering emergency grant funding to help pay for expenses such as housing, food, technology, health care, and/or child care. To receive this amount, you must complete the application process. This amount will be sent as a direct payment to you in the form of a check.

To apply for these funding opportunities (statement credit and emergency grant), you must complete the American Rescue Plan (ARP) eForm.
